 Data processing: Storage in soft- and hard-copy for accounting and report
 Deleted: Softcopy from GIZ server after 2 years, in hard-copy after 10 years according to HGB § 257(1)
 No. 1 and HGB § 257(1) No. 4.

The personal data are stored on the GIZ servers and used exclusively for the above given purposes. Any other use will be subject to renewed consent. Your data will not be used for advertising purposes. The personal data will not be passed on to third parties. GIZ uses appropriate technical and organisational measures to secure data against unintentional or intentional falsification, destruction, loss or access by unauthorised persons. Access to your personal data is restricted to GIZ staff members within the Sector Project Agricultural Trade, Agribusiness, Agricultural Finance responsible for its storage and use according to the above-mentioned purposes, handling your personal data in a confidential manner.
