The data is stored on GIZ servers. The data will not be passed on to third parties without your full agreement. The profile will be deleted immediately upon request of the respective person.

According to the EU-GDPR and BDSG (new) 2016/679, the legal basis for processing your personal data is your active consent to this declaration.

GIZ protects the data by suitable technical and organisational measures against unintentional or intentional falsification, destruction, loss or access by unauthorised persons. Access to personal data is restricted to those GIZ employees within the Sector Project 'Agricultural Trade, Agribusiness, Agricultural Finance' who must process these data in accordance with the above-mentioned purpose(s) and handle them properly and confidentially. GIZ assures that any subcontracted processing of the data will be undertaken in accordance with the EU GDPR.

Consent

I give my consent to GIZ to store and use my data in accordance with the GDPR as described above. This agreement remains valid for a period of 2 years, even if the profile was removed.

Rights declaration
